Approval of 2016 Minutes

- a) Business arising from minutes Ladies singles format
 - a. Petition was received during the year to reconsider the ladies format as participation is down due to players withdrawing/not playing because of the full round robin. This year there were 28 women registered to play.
 - b. The change was originally brought about because there was concern for the limited amount of games played in the ladies' sections.
 - c. Reminder that the district directors are supposed to represent their region as a whole.
- b) Ladies Format Alternative Options Submitted for consideration
 Option 1 28 players 6 hours play Saturday (estimated)

Round 1 – 4 divisions of 7 – estimated time of completion – 3 hours – 6 matches – everyone advances to round 2

Round 2 – re-seeded 4 divisions of 7 – estimated time of completion – 3 hours – 6 matches – top 16 cumulative points from both rounds advance to Sunday's top 16

Round 3 – Sunday – top 16 as normal

<u>Option 2</u> – 28 players – 7 hours play Saturday (estimated)

Round 1 – 2 divisions of 14 – estimated time of completion – 7 hours – top 8 from each division advances to Sunday's top 16

Round 2 – Sunday – top 16 as normal

New Business -

a) Discussion of venue fees - Affiliation fee for each District.

In order to be a member of NODA, the district must pay the affiliation fee \$150.00/district (small districts to pay \$75 if they qualify). This in part pays for our Affiliation fee for NODA to be affiliated with NDFC.

Derogatory comments on any social media will be investigated and disciplinary action may be involved depending on the severity of the offence.

c) Nationals Update 2017 – Rooms are blocked

Player Commitment Fee \$500.00

April 23rd deadline (7 Days) \$250 by the 23rd, NON-REFUNDABLE,

Remaining balance is due within 2 weeks. (May 7th).

If you miss a deadline, for any reason, it is completely your responsibility and the next alternate will be asked to replace you. Communication back to Christine is mandatory.

All players must stay in the venue at the Nationals to support all remaining players that are still in competition.

d) Team Shirts – This year's team shirts are the same as the 2015-2016 shirts. Extra shirts will be \$85 and can be purchased by anyone.

There will be a call out for designs for the 2018 shirts (it will be announced and posters placed in venue also). The membership will vote on which design to use. Suggestion was made for colour change but reminder that Northern Ontario's colours are green and gold.

e) Provincials Date – Potential weekend change

There will be a poll of members for feedback on when they would like to see the Provincials held. For example: 3rd weekend of March, Easter weekend. Should be mindful of other events (i.e. district shoots, Youth Provincials) when providing suggestions. Votes will be tabulated and majority rules.

Elections – Newly Elected

1st Vice President – Chris Arsenault will stand. Unopposed. Chris acclaimed.

Youth Director – Amanda Manzutti will stand. Unopposed. Amanda acclaimed.

Treasurer – Lynn Marshall will stand, Liz Briand nominated. Vote results – Liz Briand is now treasurer.

Additional Positions

2nd Vice-President – unexpected vacancy, membership not renewed. Matt D'Angelo has said he would step into a position to help. Matt to join as 2nd Vice-President.

Secretary – Stan unable to maintain current position for personal reasons. Chris and Christine will jointly carry out duties.

Other Business -

New Bank Account – The board of directors agrees that a new account to be set up by Treasurer – Liz Briand at the Northern Credit Union. Dual signing authorities required. Signatories to be treasurer and president.

Items for Discussion at next AGM:

Mixed Doubles format change – looking at something to change things up for a fundraising, perhaps early bird singles.

Increase of fees to \$100 per player with no Mixed Doubles.

Provincials 2018 – Timmins has first right of refusal – declined due to no director at this time
 Sault Ste. Marie – declined, unable to confirm volunteers and equipment needed.

Sudbury – accepted. Details will be provided as soon as possible.

East/West Rotation remains the same – 2018-East, 2019-West, etc.
